DMCA Policy

www.safas.io respects the intellectual property rights of others and expects users of our website to do the same. In compliance with the Digital Millennium Copyright Act (DMCA), it is our policy to respond to valid notices of alleged copyright infringement. This policy outlines the steps we take when we receive a DMCA notice and provides information on how to contact us regarding potential copyright infringements.

1. Reporting Copyright Infringement

If you believe that content on **www.safas.io** infringes your copyright, you may submit a written notification under the DMCA by providing the following information:

- A physical or electronic signature of the person authorized to act on behalf of the copyright owner;
- Identification of the copyrighted work you believe has been infringed, or, if multiple copyrighted works are covered by a single notification, a representative list of such works;
- Identification of the material that you claim is infringing, including information reasonably sufficient to enable us to locate the material on our website (such as a specific URL link);
- Your contact information, including your address, telephone number, and email address;
- A statement that you have a good-faith belief that the use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
- A statement, under penalty of perjury, that the information in the notification is accurate and that you are authorized to act on behalf of the copyright owner.

2. Response to Claims

Upon receiving a valid DMCA notice, www.safas.io will:

- Remove or disable access to the allegedly infringing content;
- Notify the user who posted the content that we have removed or disabled access to it; and
- If necessary, terminate repeat infringers' access to the website in accordance with our Terms of Service.

3. Counter-Notification

If you believe your content was removed or disabled by mistake or misidentification, you may submit a counter-notification by providing the following information to our DMCA agent:

- Your physical or electronic signature;
- Identification of the content that has been removed or disabled and the location where it appeared before removal;
- A statement under penalty of perjury that you have a good-faith belief that the content was removed or disabled as a result of mistake or misidentification;
- Your name, address, telephone number, and email address; and
- A statement that you consent to the jurisdiction of the federal district court in your location, or if your address is outside the United States, the jurisdiction of any judicial district in which **www.safas.io** may be found, and that you will accept service of process from the person who provided the original DMCA notification or an agent of such person.

Upon receiving a valid counter-notification, **www.safas.io** may reinstate the removed content within 10-14 business days, unless we receive notice from the original claimant that they have filed a court action against you.

4. Disclaimer

Please note that the DMCA process is a legal process and we may share your notification, including your contact information, with the user who posted the content in question. We encourage you to seek legal counsel if you are unsure about your rights or responsibilities under the DMCA and this policy.
